Terms and Conditions

- Acceptance as an exhibitor or vendor of the **Family Faith Fest** is subject to approval. *The first step is to complete the form on the next page and return it by September 20th.*
- The Diocese of St. Petersburg/ **Family Faith Fest** requires all vendors/exhibitors including businesses, schools, ministries, etc., to sign a License Agreement in order to participate, which includes liability insurance coverage/waiver. This agreement is part of the application process and final approval will not be granted until this form has been completed and returned.
- The park opens for set-up at 7am (sunrise) and all vendors/exhibitors must be inside the park gates no later than 8:45am to access specialized parking areas and loading zones.
- The event begins at 10am and the villages will remain open for business until the start of Mass with Bishop Parkes at 4pm.
- The park closes at sunset (approximately 7pm) and all event entertainers, volunteers, exhibitors and vendors must clear the park by this time. The Diocese of St. Petersburg/ **Family Faith Fest** accepts no responsibility for items left in the park overnight.
- This is a “rain or shine” event, and all decisions affecting public safety due to inclement weather will be made by Fest leadership and the City of Tampa.
- As per the City of Tampa Parks and Recreation Department, there will be no stakes or digging into the ground.
